HISTORICAL OVERVIEW NORTHERN CALIFORNIA TIME OF REMEMBRANCE

Vision Statement:

"Learn from the past to safeguard the future"

The coalition of Northern California Japanese American Citizens League chapters shall annually conduct Time/Day of Remembrances activities to remember the tragic lessons of the unjust incarceration of persons of Japanese ancestry during World War II and will join with other Americans in activities to ensure the basic rights guaranteed by the U.S. Constitution are not denied for any of its citizens.

Mission:

- Annually provide leadership, participation and resources, in the planning of community-wide remembrance activities and educational programs for students in Northern California.
- Develop partnerships with other institutions and organizations to coordinate, plan and conduct the community-wide program and student education program, such as, the California State University, Sacramento, Library, Special Collections, Japanese American Archival Collection, the California Museum, and the Elk Grove United School District Superintendent and Board.
- Coordinate and train volunteers to participate in the educational presentations for students and adults on the incarceration experience of persons of Japanese ancestry.
- Develop partnerships with other JACL Chapters and organizations to promote, to advocate, to
 participate and to provide sensitive and responsive support for any persons or groups experiencing
 acts of injustice. (Adopted, May, 7, 2002: representatives from Florin, Lodi, Marysville, Placer County
 and Sacramento JACL chapters).

Timeline:

1983-2002 Florin JACL chapter under the leadership of Mary Tsukamoto, planned and organized a two-part educational program regarding the incarceration of Americans of Japanese Ancestry during World War II. This was part of the education, promotion and advocacy of the redress and reparations campaign.

For twenty (20) years, a two-week educational program was presented at the Elk Grove Unified School Board Room for 5th graders and a community-wide program was held the first Saturday in March at the Florin YBA Hall.

The programs were planned in partnerships with the Elk Grove Unified School District Board and the California State University Sacramento, Library, Special Collections, Japanese American Archival Collection.

The Elk Grove Unified School District Superintendent and Board is the only school district in California who has passed a Board Resolution in support of Time of Remembrance activities. They provided time and financial support for teacher training and student field trips to participate in these activities, since 1981 to the present day.

2002

Florin chapter' invitation to surrounding JACL chapters to join in planning Northern California TOR activities, in lieu of individual chapter events. Established purpose and goals, participation requirements, operating budget and sponsorship goals.

An initial meeting on November 18,2002, was held with chapter representatives from: Florin, Marysville, Sacramento and Stockton at the Sacramento JACL office. At that time there was agreement to form a joint group of chapters to hold annual TOR program in lieu of individual chapters. Other chapters who were invited and expressed interested requiring their Board's approval: Place County, Lodi, French Camp and Solano.

Marielle Tsukamoto met with Ross McGuire, Executive Director and Kelly Bitz, Educational Coordinator regarding holding the student educational program at the Golden State Museum aka California Museum.

July 2002

First meeting of Florin, Marysville, and Sacramento chapters to organize and plan the 2003 joint Northern California Time of Remembrance program activities.

Other interested JACL chapters awaiting Board approval were, Stockton, Placer County, Lodi, French Camp, and Solano.

First organizing committee members consisted of; Florin, Marysville, Placer County, Sacramento and Stockton JACL chapters.

The California Museum for History, Women and the Arts aka Golden State Museum, became a partner in addition to the Elk Grove Unified School District and CSUS, Library, Special Collections.
